NORTHERN LIGHTS ANNOUNCES COMPLETION OF SHARE CONSOLIDATION AND DEBT SETTLEMENT

December 28, 2017

Northern Lights Resources Corp. (the “**Company**”) announces completion of its share consolidation, effective today, on a 1.75 old for 1.0 new basis. Letters of transmittal describing the process by which shareholders may obtain new certificates representing their consolidated common shares will be mailed shortly to registered shareholders. Shareholders holding their shares through a broker or other intermediary and consequently not having shares registered in their name will not be required to complete a letter of transmittal.

Following the consolidation and subject to rounding, the Company will have 24,602,502 issued and outstanding common shares.

The new CUSIP and ISIN numbers for the Company’s common shares are as follows:

In addition, the Company announces further to its news release dated November 22, 2017 that effective December 4, 2017 the Company closed its debt settlement and issued 16,617,220 pre-consolidated (9,495,554 post-consolidated) common shares to settle an aggregate of \$830,860.99 of indebtedness. All shares issued in relation to the debt settlement are subject to a statutory hold period expiring April 5, 2018.

Mr. Albert (Rick) Timcke, the Company’s President and Executive Chairman, acquired 9,138,900 pre-consolidated (5,222,228 post-consolidated) common shares of the Company (“**Shares**”) at a price of \$0.05 per pre-consolidated share, in settlement of \$456,945 of debt. Mr. Timcke now has direct ownership and control over 6,902,800 post-consolidated common shares of the Company representing 28.05% of its issued and outstanding common shares. The Shares were acquired by Mr. Timcke for investment purposes. Mr. Timcke has no present intention to acquire further securities of the Company, although he may in the future acquire or sell securities of the Company as circumstances warrant.
